FSSAI Three New Health Certificates

Requirements	28/10/2022	 Referring to the three health certificates included in the FSSAI Order of 3 August 2022 (milk, pork, fish and their products), could the FSSAI indicate if, for each of those products, it is open to: Merge the FSSAI certificates with the certificates issued by the Department of Animal Husbandry and Dairying of India (for milk, pork and their products) and with the Department of Fisheries of India (for fish and their products); and Negotiate with the European Commission harmonized certificates that would be used/certified by the competent authorities of all EU Member States? 	23/11/2022	According to the FSSAI, the food safety attestations of the certificates are uniformly applicable to all countries exporting to India, but exporting countries may add any other additional attestations, e.g. "as per the controls performed by the exporting country, according to the respective requirements of the exporting country". However, the FSSAI is open to discuss and negotiate: (1) the part of the certificates related to the consignment (not the food safety attestations); and (2) formal and mutual equivalence arrangements, acknowledging that this takes time and therefore may not provide an immediate relief. The DAHD is also working towards integrated certificate by removing all food safety conditions from their certificates). At the moment, FSSAI has agreed to accept the integrated certificate issued by exporting countries.

Food Safety and Standards (Food Products Standards and Food Additives) Regulation, 2011, and 4. Food Safety and Standards (Contaminants, Toxins and Residues) Regulation, 2011. The Compendium consolidates all the changes made to the respective Regulations.

Products - Milk and Milk Products	28/10/2022	Referring to "milk and milk products" as one of the food categories listed in the FSSAI Order of 3 August 2022, could the FSSAI confirm that "milk and milk products" are the ones defined in the FOOD SAFETY AND STANDARDS (FOOD PRODUCTS STANDARDS AND FOOD ADDITIVES) REGULATIONS, 2011?	23/11/2022	Yes, as mentioned in the Compendium.
Controls (audits, inspections)	28/10/2022	Referring to each of the three health certificates included in the FSSAI Order of 3 August 2022 (milk, pork, fish and their products), which include the attestation " <i>regular inspections/monitoring of checks</i> <i>in accordance with FSS Act, 2006, rules and</i> <i>Regulations and as per criteria specified by FSSAI</i> " that need to be signed by the certifying Authorised Official in the country of export, could the FSSAI clarify the meaning of these requirements, i.e. which requirements relate to the inspections and monitoring of checks?	23/11/2022	The requirement for inspection/ monitoring is mentioned in respective regulations and same shall be complied with. For example, the high-risk manufacturing facilities are inspected at least once a year. Therefore, the FSSAI expects that the competent authorities or third-party entities perform the inspections to the food manufacturing facilities with similar frequency and inspection shall cover all the aspects as carried out by FSSAI to ensure that it meets FSSAI's requirements. FSSAI is reviewing the list of high-risk products, including cocoa and, once the revision is concluded, it may available on website.
