

Sub-Section “QUESTIONNAIRES” of the Market Access Database (MADB)

To facilitate the Commission’s and Brazil’s management of your feedback, please do not send it by e-mail and upload one or more documents in the Sub-Section “Questionnaires” of the MADB. When doing so, please:

- Chose, in all entries (one or more entry), the third country “Brazil”, complete the rest of the entry (as shown below), and click on “Save”;
- Include, in the document or documents that you will upload in each entry, matters related to issues of export interest and concerns that may currently affect or affected in the past the approval of the labels/products for which TRIQs exist(ed) or not;
- Always indicating whether a TRIQ already exists or not, please separate the information on matters related to: **(1)** individual products of animal origin; and **(2)** horizontal/systemic (product specific or not);
- Include in the name of the file(s) you will upload the name of the product or horizontal issues of concern.
