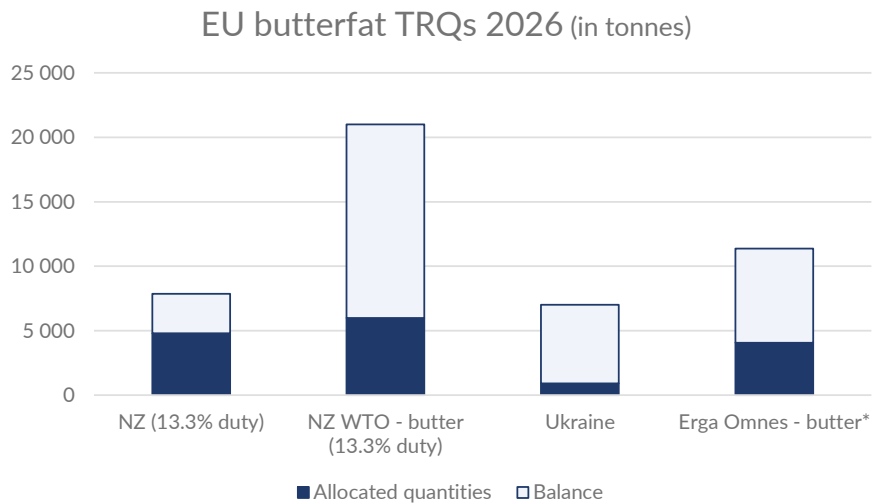

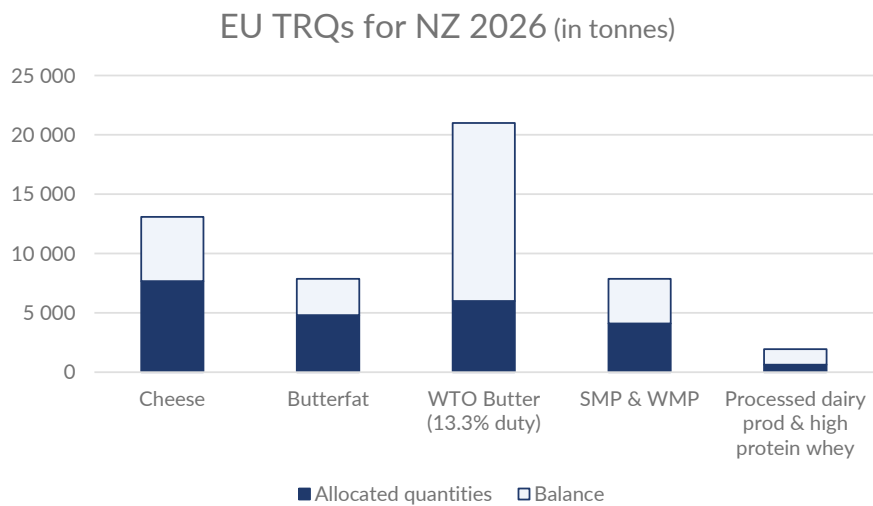

Allocation of selected EU butterfat TRQs

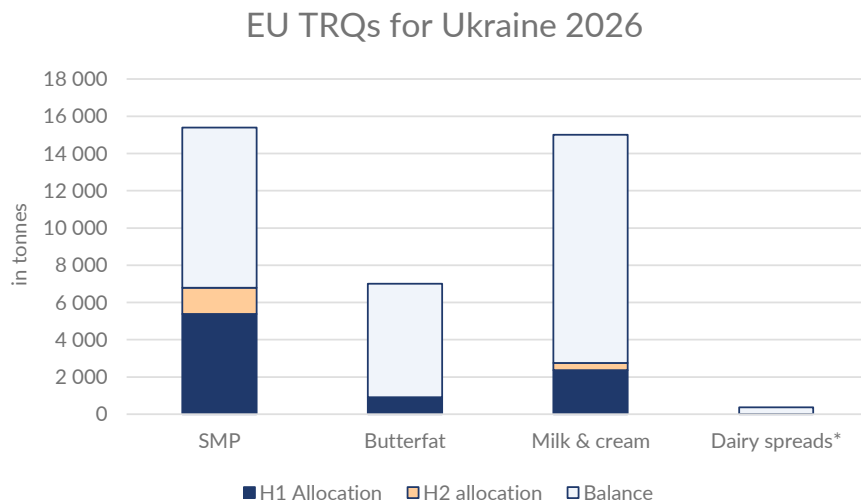

Allocation of selected EU TRQs by countries

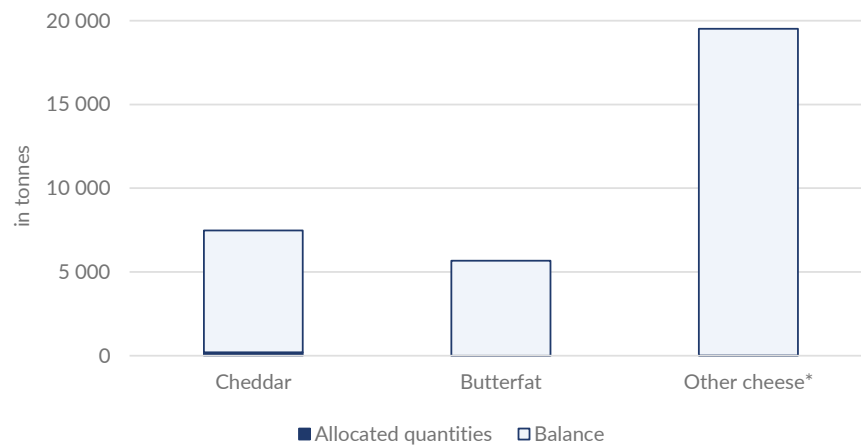

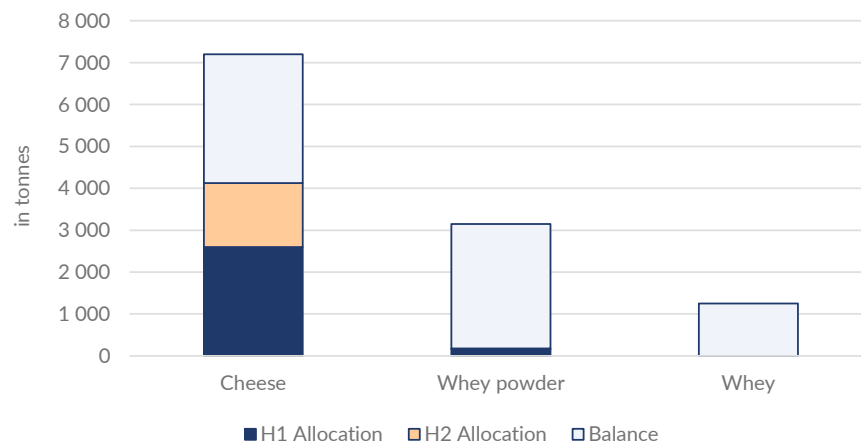
EU TRQs for Erga Omnes 1 Jul-31 Dec 2026

Quota management:

FCFS First come - first served

Tariff rate quota period:

Each TRQ is open on an annual basis with opening day either on 1 January or 1 July of each year.

For some TRQs the annual quantity is split into 2 sub-periods. At the end of the first sub-period, the remaining quantity is added to the second sub-period quantity.

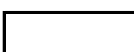
